GENERAL SALES CONDITIONS

- I. Formation of the agreement
 - A. The current general conditions are part of the agreement and are considered acceptable to the client, also in the event that it conflicts with the client's general or special conditions.
 - B. The prices and conditions are free of obligations. Each order obliges the seller only following consent on his/her part.
 - C. The weights, measures, prices and other details in folders, circulars, drawings, etc. can be solely considered as an estimated indication. This data is binding only if expressly stipulated in the contract.
- II. Sales agreement
 - A. *Retention of title*
The client's ownership rights on the delivered machines will go into effect only following payment in full of the sales price.
 - B. *Delivery - Acceptance*
 - The delivery period is stated and possibly confirmed solely as information and without surety: non-compliance thereof does not entitle the client to any recourse and is especially not a reason for dissolution of the agreement.
 - The seller has the right to suspend delivery and/or annul the agreement in case the client is found to be at fault with regard to meeting the obligations agreed upon in the agreement concluded with the seller.
 - The client is accountable for the necessary provisions that comply with legal standards, as well as for the layout of and the entrance to the premises.
 - Barring other stipulations, the applicable point of time of delivery and transfer of risks is the moment in which the products are delivered to the client. Barring a written complaint within three days after delivery, the goods are considered to be compliant with the order.
 - C. *Warranty*
The seller provides a warranty for the supplied products for a period of 1 year against any construction faults or hidden faults, starting on the date that the goods are made available. This warranty has no other consequences for the seller except the obligation to repair or replace defective parts. The seller is not responsible for faults resulting from inadequate maintenance, incorrect use or lack of supervision. The warranty expires if the client carries out repairs or alterations or lets these be carried out without prior agreement of the seller.
 - D. *Limitations of liability*
The liability of the seller is limited to the repair or replacement of products or defective parts. Under no circumstances will the seller be held liable for any type of indirect damage, including loss of use or loss of profit.
- III. Payments
 - A. *Prices*
All prices are net, excluding VAT, ex-works and including packaging.
 - B. *Payment conditions*
The Sales Agreement will be in effect only after an advance payment of the total amount of the sold machines or parts.
 - C. *Disputes*

The Court of Antwerp shall have exclusive jurisdiction with respect to any dispute between the parties as a result of the Agreement or a competent court in the place where the client resides, according to the choice of the seller. This agreement will be governed and interpreted in accordance to Belgian Law.
